

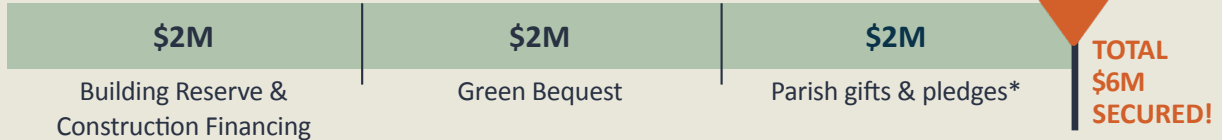

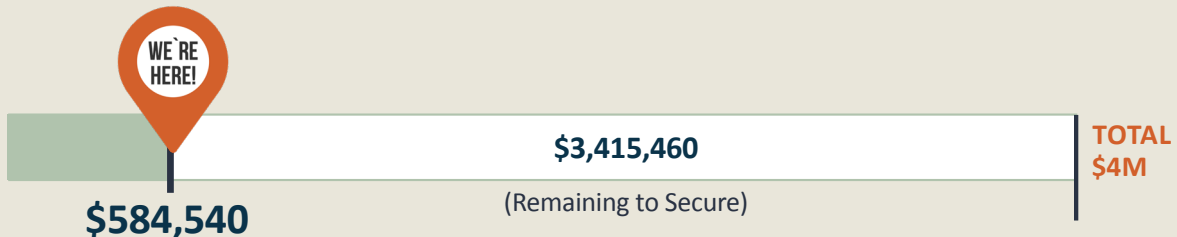
► PHASE ONE: BUILD A NEW PARISH HALL GOAL: \$6M
